



TERMS AND CONDITIONS FOR REGISTRATION

1. INTRODUCTION

These Terms and Conditions for Registration (the "**Terms**") govern registration for and participation in the event titled ESET European Cybersecurity Day (the "**Event**").

The Event is organized by ESET, spol. s r. o., having its registered office at Einsteinova 24, 851 01 Bratislava, Slovak Republic, Business Registration Number: 31333532 ("**ESET**", "**we**", "**us**" or "**our**").

By submitting a registration for the Event, you agree to be bound by these Terms. If you register on behalf of an organization, you represent and warrant that you are authorized to do so and to bind that organization to these Terms.

2. REGISTRATION AND ACCEPTANCE

Participation in the Event is subject to prior registration through the registration form made available by ESET.

You must provide complete, current and accurate information during the registration process and promptly update any information if it changes.

ESET reserves the right, at its sole discretion, to approve, reject, deny or cancel any registration at any time, including where capacity is limited, the registrant does not meet the intended participant profile, the information provided is inaccurate or incomplete, or the registration is otherwise inconsistent with the purpose, security or proper organization of the Event.

A registration is effective only once confirmed by ESET.

3. EVENT ACCESS AND CHANGES

Only persons whose registration has been approved by ESET may attend or access the Event or any related event materials, platforms, streams, recordings or other content made available in connection with the Event.

ESET may modify the Event program, speakers, format, venue, platform, schedule or other organizational aspects of the Event where reasonably necessary for operational, technical, legal, compliance, security or business reasons.

ESET also reserves the right to reschedule, interrupt or cancel the Event, in whole or in part, at any time.

4. PARTICIPANT CONDUCT

As a condition of participation, you agree that you will not:

- i. use the Event or any related website, platform or materials for any unlawful or prohibited purpose;
- ii. interfere with or disrupt any website, platform, stream, server or network used in connection with the Event;
- iii. attempt to gain unauthorized access to any systems, accounts, content or materials;



- iv. copy, misuse, distribute or make available Event content except as expressly permitted by ESET; or
- v. engage in conduct that may endanger, harass, disrupt or adversely affect ESET, speakers, partners or other participants.

ESET may suspend or terminate your access to the Event, without liability, if you breach these Terms or if ESET reasonably considers your conduct inappropriate, unsafe, unlawful or disruptive.

5. ELECTRONIC COMMUNICATIONS

ESET may communicate with you electronically in connection with your registration and participation in the Event, including by email, through the registration platform, through the Event website, or by posting notices relating to the Event.

You agree that such electronic communications satisfy any legal requirement that communications be in writing, unless applicable law requires a different form of communication.

6. PRIVACY

Personal data provided in connection with registration for the Event will be processed in accordance with ESET's applicable [Privacy Policy](#).

7. INTELLECTUAL PROPERTY

All rights, title and interest in and to the Event and all related content and materials, including any presentations, recordings, videos, documents, graphics, logos, text and other materials, are owned by ESET or its licensors and are protected by applicable intellectual property laws.

No rights are granted to you other than the limited, non-exclusive, non-transferable right to access and use the Event and related materials for their intended purpose in accordance with these Terms.

8. DISCLAIMER

To the maximum extent permitted by applicable law, the Event and all related content, materials, platforms and services are provided on an "as is" and "as available" basis, without any representation, warranty or guarantee of any kind, whether express or implied, including as to availability, accuracy, completeness, fitness for a particular purpose, merchantability, non-infringement or uninterrupted operation.

9. LIMITATION OF LIABILITY

10. CHANGES TO THESE TERMS

ESET may amend these Terms from time to time, including to reflect changes to the Event, applicable law, security requirements or business needs. The updated version will be made available on the relevant Event or registration page or otherwise communicated electronically.

Unless mandatory law requires otherwise, the amended Terms become effective upon publication or notification. If you do not agree to the amended Terms, you must discontinue your participation and, where applicable, cancel your registration.

11. GOVERNING LAW AND JURISDICTION

These Terms and any non-contractual obligations arising out of or in connection with them shall be governed by and construed in accordance with the laws of the Slovak Republic, excluding its conflict of laws rules and excluding the United Nations Convention on Contracts for the International Sale of Goods.

The courts of the Slovak Republic shall have exclusive jurisdiction over any dispute arising out of or in connection with these Terms or the Event.
